If eligible, it will transfer your information from the IRS database directly to your FAFSA. You are <u>NOT</u> eligible to use the DRT if you or your spouse filed any of the following:

- A Puerto Rican or foreign tax return.

- Call the IRS at 1-800-908-9946 to request a tax transcript.
