 Follow the prompts to register/sign-in and to request a transcript. Be sure to request the "IRS Tax Return Transcript." DO NOT REQUEST THE "IRS Tax Account Transcript." The copy can be emailed, faxed or mailed to our office.
- Call the IRS at 1-800-908-9946 to request a tax transcript.
