### Rights of Catalog

### Transfer Credit

The transfer of coursework from TCTC to SWU is seamless for Connect Program students since all college-level courses completed at TCTC with a grade of C or higher will transfer as either general education, major or general elective courses. Connect Program students who complete the A.A., A.S., or A.D.N. degree at TCTC will have completed all general education requirements at SWU except for nine credits of required religion courses.

### Formal Admission

Students are required to complete the Southern Wesleyan University admissions application at least 30 days prior to the beginning of the SWU academic term they wish to attend (available online at swu.edu). The application fee will be waived as part of the agreement between SWU and TCTC. Official transcripts from all previously attended colleges must be submitted directly to SWU's Office of Admissions as part of the application process.

By submitting this form, under the Family Educational Rights and Privacy Act (FERPA), you give permission to Tri-County Technical College (TCTC) and Southern Wesleyan University (SWU) to release your enrollment status, academic standing, transcript, student conduct records, and any other educational records to the other institution for the duration of your enrollment at TCTC for the purposes of administering the SWU CONNECT program and SWU to release your transcript to TCTC through your second year of enrollment at SWU for the purposes of reverse transfer. You further understand that while enrolled in the SWU CONNECT program, you are subject to the Student Code of Conduct of both institutions and that violations of either Code could impact your TCTC student status and SWU admission status.
